# INtime for Windows and INtime Distributed RTOS Evaluation

#### **Evaluation Period**

The evaluation period is typically 30 days. The evaluation requires the installation of a temporary license on the host where the INtime software is installed. The process consists of capturing a "fingerprint" of the host (explanation below) and creating an Evaluation license.

An evaluation request is made on the website: <a href="tenasys.com">tenasys.com</a>. You will be contacted within 2 business days and may be requested to provide additional information to ensure that the appropriate product is provided.

TenAsys will provide instructions by email with details how to download and license a full copy of the INtime SDK.

### How do you convert to a permanent license?

Mail a valid Company Purchase Order (PO) to the appropriate sales center (see tenasys.com for mailing address details) or send a copy of the PO in an email to sales@tenasys.com. The PO will be processed immediately if your company is an existing customer. New customers need to pay for the product prior to any shipment or provide the necessary information for a credit check. Upon acceptance of the PO, TenAsys will mail a package containing an installation CD with manuals and a USB/CID key to enable the license. The evaluation license needs to be uninstalled and the purchased license installed to enable the purchased INtime SDK. Email <u>sales@tenasys.com</u> for installation support.
